The information that you provide will be treated in confidence and will only be taken into account where the exemption applies.

The disclosure of criminal matters relating to children and young persons will not automatically debar you from membership unless the committee considers that the matter renders you unsuitable for membership.

We should be grateful if you would disclose any such information on return of application indicating any of the above. Failure to disclose any such criminal conviction may disqualify you from our membership and, if accepted may render you liable to immediate dismissal without notice.
